# **2026 Membership Categories**

GRAFTON COMMUNITY POOL, PO Box 9106, Fredericksburg, Virginia 22403

## **Stockholding Membership:**

- May be a family, individual or single + 1 membership.
- Each stockholding account receives one stockholder vote.
- Eligible to serve on the board of directors.
- Must pay seasonal operating dues in full or pay inactive fee to remain in good standing.

## **Provisional Annual Membership:**

- May be a family, individual or single + 1 membership.
- For any account not holding stock.
- May not serve on the board of directors.
- Not entitled to stockholder vote.
- Enjoys most other rights and privileges of Stockholding membership.
- May purchase stock if pays seasonal operating fee in full (not applicable for prorated memberships)

## **Inactive Membership:**

- For stockholders.
- Retains voting rights but cannot visit for the season.
- Limited to one year in sequence.
- Inactive status may be lifted during the season upon payment of the remaining seasonal operating fee.
